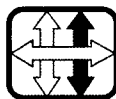

## Summary of Scorecard Assessment and Report of:

### BIRCRAFT CC

In terms of the Codes of Good Practice (gazetted on 09 February 2007) and as per Code 000 Statement 000 (clause 4 and clause 6), an enterprise automatically qualifies as a MICRO entity and deemed to have a BBEE Status of "Level 4 Contributor" having a procurement recognition of 100%, when the following criteria has been certified/verified :-

"4.1. Any enterprise with an annual turnover of R 5million or less qualifies as an Exempted Micro Enterprise (EME).

6.1. Start-up enterprises must be measured as EME's under this statement for the first year following their formation or incorporation. This provision applies regardless of the expected total revenue of the start-up enterprise.

6.2. Start-up enterprises are deemed to have a BBEE status of "Level 4 Contributor" having a procurement recognition of 100%"
